Welcome from LGNSW President

Cr Linda Scott

Welcome to the 2020 Local Government NSW (LGNSW) Annual Conference. This continues to be the most important event on our calendar, an opportunity to share ideas and determine our sector's policy directions for the coming year.

It has been an extraordinarily challenging past 12 months, with councils across our State working through the worst drought in our history, a summer of devastating bushfires and the COVID-19 pandemic, which has forced us to host this year's conference online.

Despite these challenges, councils have overall continued to punch well beyond their weight, providing essential services and infrastructure and driving a locally-led economic recovery.

It's entirely fitting that the theme of this year's Conference is 'Growing Community Resilience', something councils continue to be absolutely focussed on.

As your peak body, LGNSW has worked hard to provide a strong local government voice to the NSW Government, and to the Federal Government through the Australian Local Government Association.

I am proud of the outcomes we've been able to achieve on your behalf.

LGNSW advocacy has helped to deliver more than \$6 billion in funding for local councils and their communities. In addition, we were the only State to receive a \$395 million COVID-19 economic stimulus package.

We were also able to secure funding for councils for drought infrastructure projects; public spaces projects such as parks, town squares, footpaths, cycleways and other infrastructure; new and accelerated local roads funding; support for early childhood education and pre-school services; ongoing library funding; and funding to cover the increase in councils emergency services levy contribution.

LGNSW also saw long-awaited improvements to building standards and planning policies, including the appointment of the NSW Building Commissioner, and new powers to stop defective apartment buildings being built and sold. We paved the way for our sector to retain as many employees as possible during this period thanks to the Local Government (COVID-19) Splinter (Interim) Award and the finalisation of a new three-year Award.

These were both developed with record levels of sector engagement, alongside local government unions.

We've continued to provide essential advice to our members, including 285 legal advices. We also helped settle more than 100 workplace relations matters on behalf of councils.

These are some of the great things we have achieved with your support, despite the ongoing issues and challenges we are all working through.

While this year's Conference is limited to an online event, we have worked hard to create a streamlined and effective way to debate and vote on the motions brought by you and your colleagues. Thank you for your attendance and participation, which will help determine LGNSW's advocacy for the year ahead.

In closing, I thank the LGNSW Board, which is committed to supporting and strengthening councils across the State. I also thank our wonderful LGNSW staff, who have worked tirelessly to help us achieve so much for NSW local governments.

Finally, I thank the generous support of our sponsors. Their support of our conference enables us to meet together and set a vision for the year ahead despite these trying times.

Speakers



Scott Phillips, Chief Executive, LGNSW

Scott Phillips has 25 years' experience in the local and state government sectors, developing and leading high-performing and multi-disciplinary teams. Before joining LGNSW, Scott was general manager of Sutherland Shire Council, leading 1800 employees and managing an annual operating budget of \$250 million. Before that, he was Hornsby Shire Council general manager, which followed a distinguished public-sector career in the planning and development profession.

His commitment to a strong workplace culture, together with his extensive industry and operational experience, complements the existing expertise and commitment to local government shared by the LGNSW Board and staff.



The Hon Gladys Berejiklian, Premier, NSW

Gladys was first elected to the NSW Parliament as Member for Willoughby on 22 March 2003.

She was elected Leader of the Parliamentary Liberal Party on 23 January 2017 and sworn in as the 45th Premier of New South Wales. On 23 March 2019, Gladys was elected as Premier of New South Wales when the Liberals & Nationals won the 2019 state election. It was an historic election victory which secured a third term for the Liberals & Nationals for the first time in nearly 50 years.

Gladys had previously served as Treasurer and Minister for Industrial Relations in the Baird Government since April 2015. Prior to that, she was appointed Minister for Transport following the election of the O'Farrell Government in March 2011 and served in that role for four years.

She is a Master of Commerce graduate from UNSW and prior to entering Parliament worked as a General Manager for one of Australia's largest financial institutions. Gladys has also completed studies in Government and Public Administration (B.A., Uni. Syd).

Gladys lives in Willoughby and has had a life-long association with the local area.



Cr Linda Scott, President, LGNSW

Cr Linda Scott (B.Sc. (Psych.), GAICD, JP) is a City of Sydney Councillor and former Deputy Lord Mayor, first elected in 2012 and re-elected in 2016. She is the elected President of Local Government NSW and elected Vice-President of the Australian Local Government Association (ALGA).

Linda is a regular guest on Sky News and a committed advocate for the public good. She serves on the boards of CareSuper, the NSW Environmental Trust, the NSW Public Service Medal Committee, and the Road Freight Industry Council and is an alternate delegate to the Central Sydney Planning Committee.

Linda is a strong advocate for local government and has successfully increased public funding for libraries, secured more local government control in planning decisions and a Parliamentary Inquiry into local government electoral funding. She has successfully fought for city action to create affordable housing, increased early education, care centres, new skating facilities and use of historical and indigenous languages in city parks and landmarks while increasing city funding for action on climate change.

Linda won Labor's first community preselection, where more than 4,000 people elected her to be Labor's candidate for Lord Mayor of Sydney in the 2012 NSW Local Government Elections. She is also the Deputy Chair of Labor's Sustainable Communities Committee.

Linda lives with her husband and two children in Newtown, Sydney. She enjoys bushwalking, swimming and live music.



Cr Jerome Laxale, Treasurer, LGNSW

Cr Jerome Laxale has served as Treasurer of LGNSW since October 2019 and is committed to local government. After running a family business for a decade, Jerome was first elected to the City of Ryde in 2012. By the end of the current term, he will have served five years as mayor and has been an enthusiastic and accessible elected official during his term on council. He has also previously served as vice-president of a metropolitan Regional Organisation of Councils and currently sits on the advisory board of Venture Café Sydney. In 2018, he was appointed as a director of StateCover Mutual and currently chairs its Risk Committee.

Speakers



The Hon Shelley Hancock MP, Minister for Local Government

After serving 17 years as a councillor, the Minister knows local councils are crucial to the NSW economy and improving the lifestyle and amenity of local communities. The Minister's key priority is to guide and support the sector that invests more than \$11 billion each year in infrastructure, facilities and services, and employs more than 45,000 people across the State.

First elected in 1987 to Shoalhaven City Council as a Ward Three Alderman and subsequently as Councillor, the Minister served in numerous roles including Deputy Mayor (2000-2001). She also chaired a number of committees including Council's Rural Fire Service Strategic Planning Committee.

Minister Hancock was elected to the Parliament of NSW as the Member for the South Coast in 2003. On May 5 2011, she was elected Speaker of the NSW Legislative Assembly – the first female Member to be nominated to the role.

On April 2 2019, Shelley was sworn in as Minister for Local Government as part of the Berejiklian NSW Government. The Minister has a number of responsibilities, including Coastal Management, Public Reserves, Graffiti Control, Companion Animals and of course guiding and assisting the state's 128 local councils.

The Minister will continue to engage and collaborate with the local government sector on the best ways government can support local councils to better service their local communities now and into the future.



Greg Warren

Greg was born and raised in Dubbo, Central West NSW where he lived until enlisting in the Australian Regular Army at the age of 17, serving in both the Royal Australian Infantry Corp and Royal Australian Corp of Transport. After his discharge from the military, Greg moved to Campbelltown and worked as a truck driver whilst undertaking his business studies. He still resides in the area, having raised his two children, Bailey and Darcy who were both born in Campbelltown Hospital.

While completing his studies, Greg worked a number of jobs to pay his own way and support his family, including as a fuel operator and truck driver carting coal up and down Appin Road. His first-hand knowledge of the notorious road further enhanced his understanding of the importance of upgrading local roads and major arterials – like the Appin road among others.

Greg is proudly a grassroots Member of Parliament - from the community, for the community. He joined the Labour movement and the Australian Labor Party (ALP) after his discharge from the military and upon joining the civil workforce. More broadly, Greg has a fundamental belief in social justice, equality, compassion, liberty and enterprise to advance the lives and aspirations of communities and families.

Prior to entering the NSW Parliament, Greg was a Mayor, Deputy Mayor and two term Camden Councillor, with a strong and consistent passion for fighting to ensure local families, businesses and community groups got the services, facilities and infrastructure they deserved.

In July 2019, Greg was appointed to the Shadow Ministry by NSW Labor Leader Jodi McKay. Greg was appointed as the Shadow Minister for Local Government, the Shadow Minister for Veterans and the Shadow Minister for Western Sydney. As a former mayor, former member of the army and current resident of Western Sydney, all three portfolios are close to Greg's heart.




David Shoebridge, MLC

David Shoebridge is a Greens MP in the NSW Legislative Council. He is the Greens NSW Spokesperson for Local Government and crown lands as well as for Aboriginal justice, forests, compensation and more.

David was elected to Woollahra Council in 2004 and re-elected in 2008. During his eight-plus years as a councillor, he served one term as Deputy Mayor of Woollahra.

His recent work includes exposing the highly politicised allocation of funding to councils under the Stronger Communities and Stronger Country Communities Grant schemes. He is the chair of the inquiry into these and other grant schemes with a view to improving probity and accountability.

He works closely with Greens councillors and mayors across the state, including in response to the devastating 2019/20 bushfires. He is a strong supporter of local government and an advocate for greater financial and political autonomy for NSW councils.

Shane Fitzsimmons, Commissioner, Resilience NSW

Commissioner Fitzsimmons was appointed Resilience NSW's inaugural Commissioner and Deputy Secretary Emergency Management in May of 2020. He chairs the State Emergency Management Committee, the State Recovery Committee and National Emergency Medical Committee.

The appointment to Resilience NSW follows a distinguished career with the NSW Rural Fire Service as well as council and director roles across state and national emergency management authorities.

Commissioner Fitzsimmons' career has been acknowledged with the NSW Rural Fire Service Long-Service Medal, recognising 30 years of service; the National Medal, recognising more than 35 years of service; and, the Australian Fire Service Medal (AFSM). He is also a Paul Harris Fellow and holds a Paul Harris Fellow Sapphire through the Rotary Clubs of Berowra and Sydney.

He is a Royal Humane Society of NSW Inc. Councillor and patron of two children's charities, Kids Xpress and Coffee 4 Kids.

In 2020, he was named Australian Father of the Year 2020 through The Shepherd Centre and NSW Australian of the Year.



Leanne Barnes OAM, GM, Bega Shire Council

Leanne Barnes has been general manager at Bega Valley Shire Council since January 2014. Leanne stepped up into the job after 10 years as a group manager with the council.

In 2009 she was awarded the NSW Ministers' Award for Women in Local Government in the regional/rural staff category. She has held leadership and management roles with Planning NSW, the Victorian Country Fire Authority, in local government in Victoria, with the Victorian Ministry for the Arts and in TAFE.

Leanne has considerable experience on several sporting and cultural boards. Her representative water polo career includes national and international team memberships, and she was the coach of the Victorian State team and the national team. Between 1982 to 1997 she led the international and Australian campaign for the inclusion of women's water polo on to the Olympic Games program – a campaign that was ultimately successful for the 2000 Olympic Games resulting in the first Olympic Gold Medal for Women's Water Polo.

She was awarded an Order of Australia Medal (OAM) as part of the Queen's Birthday Honours List in 2019.

Recently, Leanne provided exceptional leadership to council and the Bega Valley Shire through the unprecedented natural disasters experienced in the shire, including the east coast low, Tathra and district bushfires, Black Summer Fires and COVID-19.

Her commitment and experience in community-led recovery is evidenced by her holding roles as chair of Bega Valley Shire Local Recovery Committee, Southern NSW Regional Recovery Committee General Managers Working Group and deputy chair of Southern NSW Regional Recovery Committee.



Michael (Mick) Willing, NSW Assistant Police Commissioner, Bushfire Recovery

As State Recovery Coordinator and head of the NSW Disaster Recovery Office, Michael is leading the state's recovery from the 2019/20 bushfire disaster. He was appointed to this role by the NSW Premier in January 2020, and oversees a whole-of-government task force supported by the largest mobilised Australian Defence Force contingent since World War II.

Michael joined the NSW Police Force in October 1990 and has had a distinguished law enforcement career, including work for the NSW Crime Commission, several Local Area Commands, and was the longest-serving commander of the Homicide Squad in the State Crime Command.

In 2017, Michael was appointed as the Commander of the Counter Terrorism and Special Tactics Command and acted as a senior adviser to the Australia and New Zealand Counter Terrorism Committee.

In 2019, Michael was appointed Commander of the NSW Police Force Central Metropolitan Region where he was responsible for leading and delivering complex policing operations for major events.


