

# AWARD NOMINATION FORM 2018

Nominations for awards at this year's Local Government Aboriginal Network Conference being held in Narrabri on 12th - 14th September 2018 will be accepted up until 12 noon Friday 20th July 2018.

## Criteria

When making a nomination you must consider the following criteria:

- 1. Council** - a body incorporated under the Local Government Act 1993 (NSW) that has worked with the Aboriginal community on a project or projects to make significant changes in employment and economic opportunities or law and order or cultural heritage revival and protection or Council programs and service deliveries and/or reconciliation within their Council area.
- 2. Council Employee**
  - a) Council Indoor Employee** (Aboriginal and Torres Strait Islander) - An Aboriginal employee of a body incorporated under the Local Government Act 1993 (NSW) who has given distinguished service by achievement within their work area over and above their job requirements.
  - b) Council Outdoor Employee** (Aboriginal and Torres Strait Islander) - An Aboriginal employee of a body incorporated under the Local Government Act 1993 (NSW) who has given distinguished service by achievement within their work area over and above their job requirements.
  - c) A non-Aboriginal Employee** - An employee of a body incorporated under the Local Government Act 1993 (NSW) who has given distinguished service by achievement within their work area over and above their job requirements.
- 3. Councillor** - An Aboriginal Councillor of a body incorporated under the Local Government Act 1993 (NSW) who has made significant contribution to their Council area by their commitment and hard work as a Councillor.
- 4. Council Partnership** - A Council working in partnership with an external partner/s (not for profit, government department, community group, business etc) to make a significant contribution to Aboriginal community/ies.
- 5. Young Achiever (under 30 years old)** - A young Aboriginal person, an employee, or working in partnership with a body incorporated under the Local Government Act 1993 (NSW) who has/is making a significant contribution to Aboriginal community/ies.
- 6. Cr Pat Dixon Lifetime Achievement Award** - For a person who has worked in Local Government for a long period of time and has made such an improvement on Aboriginal Affairs issues.

**Who can make the nomination?** Any person or organisation can make a nomination.

**Nominations close** Nominations will not be accepted after 12 noon Friday 20th July, 2018.

**Nominations are** to be no more than 250 words; you can include photos, brochures, flyers, newspaper articles etc as supporting documentation.
