

## What is Modern Slavery





#### **Forced Labour**

•Any work or services which people are forced to do against their will under the threat of some form of punishment.



#### Debt Bondage - or bonded labour

•People borrow money they cannot repay and are required to work to pay off the debt, then losing control over the conditions of both their employment and the debt.



#### **Human Trafficking**

•Transporting, recruiting or harbouring people for the purpose of exploitation, using violence, threats or coercion.



#### **Descent based Slavery**

•Where people are born into slavery; they remain in slavery by descent.



#### **Child Slavery**

•When a child is exploited for someone else's gain. It can include child trafficking, child soldiers, child marriage and child domestic slavery




#### Forced or early marriage

•When someone is married against their will and cannot leave the marriage. Most child marriages can be considered slavery.

## The Problem - Australia



 The Global Slavery Index 2018 estimates that on any given day in 2016, there were 15,000 living in conditions of modern slavery in Australia.

  - USA: Federal regulations and Californian TISC law
  - UK: Modern Slavery Act introduced in 2015
  - France: Duty of Vigilance Law 2017
  - The Netherlands: Child Labour Due Diligence
  - EU: Conflict Minerals Regulation 2021
  - Locally here in Australia:
    - NSW Modern Slavery Act (under inquiry)
    - Commonwealth Modern Slavery Act 2018

### Businesses and other entities will fall under...




#### Commonwealth Modern Slavery Act 2018 (1 January 2019)

- Businesses and other entities with AUD\$100m+ annual turnover
- Includes government

#### NSW Modern Slavery Act 2018 (awaiting regs, under inquiry)

- Businesses with AUD\$50+ million annual turnover
- Penalties up to \$1.1 million for noncompliance may apply
- NSW Government Agencies must take 'reasonable steps'
- Anti Slavery Commissioner





#### The Modern Slavery Statement must describe:

- The entity's structure, operations and supply chains
- The potential modern slavery risks in the entity's operations and supply chains
- Actions the entity has taken to assess and address those risks, including due diligence and remediation processes
- How the entity assesses the effectiveness of those actions.

## Modern Slavery Act 2018 - Key elements



Mandatory Annual Reporting on actions taken to assess and address risks of Modern Slavery in Operations and Supply Chains with sign-off by the entity's governing body

- Effective 1 January 2019 onwards, reports due within 6 months of EFY
- Minimum reporting threshold is AUD\$100million annual turnover
- Public repository of reports to be maintained by the government
- Dedicated Government Business Engagement Unit established to aid businesses with compliance
- Commonwealth departments will be required to report under the Act
- No financial penalties but a Ministerial 'show cause process' is included
- 2 parliamentary Committee Inquiries conducted
- Extensive consultation
