Why create a guide?

Research conducted by the Institute for Sustainable Futures, University of Technology, Sydney <u>Barriers</u> and <u>Drivers to Sustainability in Local Government</u> identified one of the top barriers in relation to achieving sustainability in Local Government was lack of senior management support. On the other side of the coin having senior management support can also be your biggest driver or enabler.

Therefore is it extremely important that sustainability practitioners have guidance about the strategies and skills required to influence senior staff.

What is senior management support?

Senior management support can be described as the level of personal commitment, knowledge and leadership provided by senior management, in particular the General Manager of the council. Supportive management recognises and rewards staff achievements in the area of sustainability.

2. Internal training and awareness raising	Internal sustainability training can raise the profile of sustainability issues. Involving senior management is essential to give training creditability. 4. Gain recognition and positive publicity	Submitting and winning awards can help get sustainability recognised by senior management.
